2013-2014 Preliminary Budget Discussions Underway

Budget proposes cuts in expenditures and the addition of two new revenue sources

The City's preliminary two-year budget for 2013-2014 was distributed at the October 8 City Council meeting. This proposed budget maintains basic levels of service, such as road maintenance and police. The proposed budget also makes investments in economic development, roads, parks, and surface water facilities.

Despite several years of declining General Fund revenues, the City has held down expenditures and maintained the City's healthy financial position. However, the continued accumulation of difficult economic conditions, including declining revenues and rising fixed costs, have made balancing this budget challenging.

The Street Fund, which pays for maintenance and rehabilitation of the City's roads, has seen declines in its fund balance in recent years. The City's General Fund has been subsidizing the Street Fund, but the challenges described above make it difficult for the General Fund to continue transferring money to the Street Fund.

To bridge the gap, the proposed budget recommends additional cuts in expenditures, and it also proposes two new revenue sources to help pay for road maintenance needs: 1) Transportation Benefit District (TBD) funding and 2) a 5% franchise fee on water and sewer utilities.

As reported to you in the Summer newsletter, the City Council voted to form a TBD in April of this year. Funds raised by the TBD would help pay for the City's transportation needs, including [article continued on page 2](#)



Sammamish River Bridges: City staff met with the King County Bridge Inspection group to discuss their recent inspection of the Sammamish River Bridges on 68th Ave NE. There are two separate structures for north and south bound traffic. The "younger" East Bridge's condition is acceptable. The West Bridge, constructed in 1938, continues to age and show more signs of wear.

Currently, the City is working with the County to perform the following for the West Bridge: a new load rating study, an update of the bridge monitoring plan, and additional analysis of the pilings and the superstructure (bridge deck and girders) in order to create a short-term maintenance list.

While it is not yet known when the West Bridge will need to be replaced, the City has begun researching options for funding.

City Council Provides Guidance on Kenmore Village Site

The 9.6-acre City-owned Kenmore Village properties are located at the northwest corner of 68th Ave NE & NE 181st Street in the heart of downtown Kenmore. On June 11, the City entered into a Purchase and Sale Agreement with Kenmore Camera owners for the sale of 1.24 acres of the Kenmore Village property. Assuming the sale is finalized, this allows Kenmore Camera to renovate one of the existing buildings and expand its retail business and classes in downtown Kenmore.

On June 14, Council approved an action plan with the objective of bringing the remaining Kenmore Village property to market in a way that advances the City's downtown goals. Following several public meetings seeking community input in July, the Council affirmed the following Position Statement on September 6,

road maintenance and rehabilitation. The City Council is currently evaluating potential funding options for the TBD, including a \$20 annual vehicle fee. For more information on the TBD, visit the City's website at www.kenmorewa.gov.

In addition, the City Manager is proposing a 5% franchise fee on water and sewer utilities. Currently, there is no utility tax or franchise fee in the City for water and sewer utilities. The purpose of a franchise fee is to pay for the cost of administering a franchise (in this case with Northshore Utility District) and for impacts on the City's infrastructure, especially roads.

As proposed, a franchise fee for water and sewer will be paid to the City by Northshore Utility District (NUD), but the cost would be passed directly on to the rate payers. The cost of the proposed franchise fee to a typical household would be about \$4.32 per month.

In total, Kenmore's overall utility taxes and franchise fees for all of its utilities (electric, water, sewer, garbage, natural gas, etc.), is the lowest among its next-door neighbors. Even with the proposed 5% franchise fee for the water and sewer utilities, Kenmore's rates, using a weighted average across all utilities, will still be lower than its next-door neighbors. Expenditure reductions, combined with the two new revenue sources above, will help maintain basic services and make significant headway toward achieving the City Council's goals. Kenmore Going Forward with Economic Development Steps

The City Council's top goal for 2012-2013 is to implement the 2009 Economic Development Strategy. With encouraging signs in the economy, some exciting things are happening on the local business front:

Kenmore Camera

Kenmore Camera has been honored as one of three finalists for Small Business of the Year in the King County Executive's Small Business Awards. This is the second year of the awards program for small businesses throughout King County, and 130 nominations were submitted for awards in 7 categories.

Kenmore Camera is an example of Kenmore's legacy of successful, multigenerational family-owned and operated businesses, and Jim and Martha Donovan have underscored their commitment to the community by entering into an agreement to purchase 1.24 acres from the City in the Kenmore Village property. Renovating the existing building formerly occupied by Grocery Outlet will provide more than three times the space of their existing store, and will accommodate many of the classes they offer throughout the year. The transaction will close following a feasibility period, which the City and the Donovan's recently extended to January 2013.

Business Incubator Program

The City Council approved a 2-year pilot business incubator program in Kenmore,

focusing on start-up technology ventures. Providing business practice consultation, mentoring and shared work space, business incubators offer networking opportunities and support to new companies. We will continue to work with Bastyr University and the technology industry to establish a longer term program. Stay tuned for news on the launch of the pilot program!

Business Open House

The next Business Open House is scheduled for **Tuesday, October 30 from 6:30-7:30 p.m.** at Kenmore City Hall. The Open Houses have been well attended and positive opportunities for local business networking. The Open House will include a presentation by the City Manager on Kenmore business climate and why local businesses need to stay connected and help each other.

We are also excited that a new Kenmore Committee of Greater Bothell Chamber of Commerce members is meeting on a regular basis. Annie Harkess, Key Bank Kenmore Branch Manager, is instrumental in getting these discussions underway. We are also encouraging other efforts for local businesses to meet and lay the groundwork for forming an organization.

Business Registration Program

The Council will discuss a proposal to institute a nominal fee Business Registration program later this year, in conjunction with the Washington Department of Revenue's Master Business License. This will help us to keep in contact with local businesses, and will also assist us in designing strategies that will bring more business to Kenmore.

consistent with downtown goals and reflective of the community's vision for the property: **"Kenmore Village is a walkable place with a public square where Kenmore area residents and workers can meet their daily needs and see one another face-to-face."** Also on September 6, Council reviewed specific actions the City should take or commit to before putting the property on the market for sale. Specific actions include: regulatory changes and incentives; investment in amenities and infrastructure; marketing/messaging; dialogue with neighboring users about their needs; and reaching out to potential tenants.

On October 1, Council gave direction to move forward with a process for selling the property. The initial step in the process is hiring an experienced, regional broker to assist the City in finding prospective buyers for the Kenmore Village property. The City will then request prospective buyers to submit their qualifications and select several prospects to be interviewed. Following the interview process, the top two or three prospective buyers will be asked to

submit proposals and monetary offers for the property. Following evaluation and negotiations, the City will enter into a letter of intent with the selected buyer, leading to a purchase and sale agreement.

The City's goal is to be under contract for sale of the property by April 2013. In partnership with the selected buyer, the City will also solicit community input in planning the public square for Kenmore Village.

The City is well-positioned to facilitate the arrival of new investment to the Kenmore Village properties and the downtown quadrants. The goals and action plan outlined above will assist in attracting commercial and residential investment that will lead to a more vibrant downtown.

Improvements at the 61st NE Ave & NE 181st Street Intersection

The City is currently constructing improvements in the 61st Avenue NE and NE 181st Street intersection. There are two components of these improvements. First, a traffic signal will be installed at this intersection. This signal, along with new left turn lanes both northbound and southbound on 61st Ave NE, will improve vehicular and pedestrian safety. Second, a new and larger underground stormwater culvert is being constructed across the east leg (NE 181st Street) of the intersection. This new culvert replaces existing culverts that are very old and failing. These culverts carry a stream that continues to flow toward Lake Washington. The new culvert will meet current standards, including those associated with fish-bearing streams.

There is presently only one lane available in each direction on 61st Ave NE north of the intersection. The current schedule calls for a traffic control plan to be in place until mid-December. NE 181st Street is closed between 61st Ave NE and 62nd Ave NE. This closure is required to allow for construction of the culvert. This section of NE 181st Street is anticipated to reopen in late October or early November.

City staff expects the new traffic signal to be operational in January, 2013. Once the signal is turned on, the public will have full use of both 61st Ave NE and NE 181st Street. Final paving and striping will be completed in the spring when weather permits.

The construction traffic plans create inconveniences, and the project team appreciates your continued understanding as construction moves forward. Please drive safely through the construction zone and obey all traffic signs and traffic control personnel. There will always be access to businesses within the project area, and they remain open to serve you. Kenmore Navigation Channel and Lake Washington Sediment Testing

The Washington Department of Ecology and City of Kenmore are moving forward this year with testing and analysis of sediment from the lake bottom and selected water samples. This project, with the cooperation of the State Department of Health and US Army Corps of Engineers, will provide information on the condition of sediment in Lake Washington off Kenmore's shoreline. The City has been working with our Congressional delegation, the US Army Corps of Engineers, and King County over the past several years to have funds included in the Corps' budget to perform maintenance dredging in the Kenmore Navigation Channel, which was constructed by the Corps in the early 1980s. Analyzing sediment samples from the Channel will help determine the estimated cost of the maintenance dredging.

Samples will also be taken from the waterfront near Log Boom Park/Harbour Village Marina area and in the Sammamish River area. The State Department of Health will prepare Health Assessment reports for the Kenmore Industrial Park/Lakepointe site and the Log Boom Park area once the samples have been analyzed. Highway 522 Improvements Update

While there has not been major construction on the 522 corridor itself for a couple of years, the City has been working behind the scenes toward construction of the West Segment (57th to 65th Avenues NE, including the north and south legs of the 61st/522 intersection).

The current project under construction, to install a traffic signal at 61st Avenue and NE 181st Street, is a component of the West Segment. This signal is anticipated to be active early in 2013 and was partially funded by a \$650,000 appropriation from the State legislature.

In addition to this work, the City has received two grants for the West Segment. The first is \$2.5 million to acquire the property rights for the project. Property rights include acquisition, temporary construction easements, utility, and wall easements. The acquisition work for the West Segment is anticipated to begin in late 2012/early 2013. The second source of funding received is a \$1.1 million appropriation from the State legislature to improve the traffic signal infrastructure at 61st Avenue NE and 522. The City is working to leverage these funds to create a funding package to move forward with construction of a piece of the West Segment from 61st to 65th Avenue NE.

SR 520 Bridge Activity at Lakepointe

Construction activities for the new SR 520 floating bridge are happening at locations throughout Puget Sound. In Kenmore, construction activities continue at the Kenmore Industrial Park, also known as Lakepointe. The contractor, Kiewit/General/Manson (KGM), is building precast concrete elements, including anchors and roadway deck sections.

Construction of the final four gravity anchors was completed in July. At this time, all eight gravity anchors have been placed in their final locations on the bottom of Lake Washington. To date 22 fluke anchors have been constructed; 13 of these anchors have been transported to the SR

520 Bridge construction site on Lake Washington. As of the week of October 8, crews plan to begin constructing up to two fluke anchors a week. Shaft anchor construction is complete and project-related barge traffic is expected to decrease.

In early October, a new gantry crane arrived on-site. This crane will be used during the construction of the roadway deck sections. Construction of deck sections is planned to begin this winter. The SR 520 Floating Bridge and Landings Project replaces the existing floating bridge and approaches from the future west approach structure east of Foster Island in Seattle to Evergreen Point Road in Medina. Help Keep Drains Clear of Leaves to Prevent Urban Flooding

Clean storm drains help prevent localized flooding. City crews work to keep storm drains clear, but with over 4,000 drains in Kenmore, we could use your help! With your assistance, we can keep streets safe and clear and can reduce property damage caused by flooding.



What is a storm drain?

Storm drains are rectangular grates with slats and are normally near the edge of the street. These grates collect water, which then flows to the nearest stream or lake.

What should I do with all of the leaves?

- Check storm drain grates frequently to make sure they are free of leaves and debris.
- Do not remove the grate from the storm drain opening – this does not unclog the system and creates a hazard for everyone.
- Rake leaves away from storm drains near your house or business. (Do not rake or blow leaves from your property into the street. Our street sweeper cannot pick up large piles of leaves.
- Dispose of leaves in your yard waste container or compost bin.

Street Sweeping

The City will continue to provide street sweeping service, not only to keep streets clean, but also to keep debris from blocking the storm drains and ditches to help minimize any flooding. Street sweeping begins mid- to late-October and continues through January.

To Report Severe Flooding

If localized flooding is severe and you are unable to clear the drain, please call Kenmore City Hall at 425-398-8900 during business hours, or after hours call King County Dispatch at 206-296-8100.

Free Sandbags Available to Kenmore Residents

The City of Kenmore has deployed over 2,000 sandbags at five designated locations for use during the flood season. Please notify the City prior to taking sandbags by calling 425-398-8900. This will allow the City to track the number of sandbags used and to refill the locations.

Downed Power Lines Stay Clear - Stay Safe

High winds have already caused power outages in our area. As a reminder, if you come across a downed power line, stay as far away from it as you can and call Puget Sound Energy at 1-888-225-5773. Assume it is live. Never touch a downed power line or anything near it.

Do not drive over downed power lines. Should a power line fall on your car when you're driving, stay in the car until help arrives.

If a person or pet comes in contact with a power line, stay clear and call 911 immediately. Do not touch the victim or the wire.

Prescription Drug Drop Box Now Available at Kenmore City Hall

Residents of Kenmore now have a free and easy way to properly dispose of their unused prescription drugs. The City has installed a prescription drug drop box in the lobby of City Hall, 18120 68th Ave NE. Turning in expired or unused prescription drugs for disposal is the only secure and environmentally sound way to dispose of leftover medicines. Residents may drop off medication Monday through Friday from 9 a.m. to 5 p.m., excluding holidays, no questions asked. We are able to accept any and all prescription drugs or other medications, except for needles, fluids or inhalers.



Protect our kids, families, and the environment. Unused or expired prescription medications are a public safety issue, leading to accidental poisoning, overdose, and abuse. Prescription drug abuse is the fastest-growing drug problem in the country. In Washington State, 11 percent of teens use prescription drugs for nonmedical reasons – a rate among the highest in the nation. Over half of teens abusing prescription drugs get them from a family member or friend, often without their knowledge. Unwanted prescription drugs left in the home endanger our children, seniors and pets. Over half of the 37,000 calls to the Washington Poison Center in 2009 were for young children poisoned by medicines found at home. The elderly are also at risk of accidental poisonings, and human medications are the leading cause of pet poisoning.

It's important to properly dispose of drugs. Unused prescription drugs thrown in the trash can be retrieved and abused or illegally sold. Unused drugs that are flushed contaminate the water supply. Proper disposal of unused drugs saves lives and protects the environment.

Meeting & Other Information

Kenmore City Council meets on the second, third, and fourth Mondays of the month at Kenmore City Hall, 18120 68th Ave. NE. The second and fourth Mondays are regular meetings. The third Monday is a study session. Meetings are open to the public, and public comments are accepted at the beginning of the regular meetings.
