|   |   | Use of streets, parks or rights-of-way: No peddler, solicitor, registered solicitor or transient merchant shall have any exclusive right to any location in the public streets, parks or public rights-of-way, nor be permitted a stationary location, nor be permitted to operate in any congested area where operations might impede or inconvenience the public. For the purpose of this section the judgment of a law enforcement officer, exercised in good faith, shall be conclusive as to whether the area is congested or the public impeded or inconvenienced. |  |  |
|   | <b>Exemptions:</b> Except where noted the following shall be exempt from all provisions of this chapter (KMC 5.85):  1) Officers or employees of the city, county, state or federal government, or any subdivision thereof when on official business; 2) Charitable, religious, nonprofit organizations, any political campaign on behalf of (or in opposition to) any candidate for public office or other similar civic, charitable, or nonprofit organizations shall be exempt from all provisions except the section pertaining to compliance with "No soliciting" signage. |  |  |  |
|   | <b>Enforcement and penalties:</b> Violation – Penalty. Violation of this chapter is a misdemeanor and any person, business, firm or corporation who violates any of the provisions herein shall upon conviction be punished by a f of up to \$1,000 and/or imprisonment for a term not to exceed 90 days  |  |  |  |
