It was acknowledged that everyone had reviewed the Task Force Charter.

### **Historical Background:**

The City Manager, Rob Karlinsey, discussed the history of how the Task Force began in 2020 and the current need to involve the Community and organize another Task Force to help keep City expenditures from exceeding revenues in future years.

## Financial Sustainability Plan and Forecast:

Melinda Merrell reviewed the six-year financial forecast and explained the 5% inflationary rate used. Task Force members will be provided with Excel versions of the forecast.

#### Other discussion:

Future meeting topics were discussed along with the importance of Public Engagement. EMC research will be conducting a random sample survey of residents soon.

Task Force communication and e-mail protocol along with the Public Records Act were discussed. City e-mail addresses are being set up for the FSP group as well as individual members.

#### **DEIA Toolkit:**

Melinda Merrell reviewed the DEIA Equity Framework Tool and the importance of taking it into consideration when looking at financial options, especially being aware of who will benefit or be burdened by decisions.
