On July 23, 2024, the Kenmore Hearing Examiner notified the Applicant, Appellant, and City that he plans to issue an Order of Dismissal based on lack of jurisdiction under the Kenmore Municipal Code. For this reason, the appeal hearing has been cancelled.

Frequently Asked Questions (FAQs)

What project is this for?

Glacier Northwest (CalPortland) plans to dredge approximately 800 cubic yards of sand, gravel, and small amounts of sediment material within the Lake Washington berthing area to provide safe passage for vessel ingress and egress (maintenance). Why am I receiving this notice?

The City's SEPA¹ determination was appealed on 6/17/2024. You are receiving this notice because:

- You are a party of interest for this project (e.g., you requested to be notified), or
- You live or own property within 1,000 feet of the subject property.

Is the appeal hearing still going to happen?

We don't think so. Because the Hearing Examiner plans to issue an Order of Dismissal, he has cancelled the July 30 and August 19 hearing dates. The City will upload a copy of the Order of Dismissal online when it is issued. In the unlikely scenario where the Hearing Examiner decides not to dismiss the appeal, the City will notify you of the new hearing date(s).
